3. Contest participant attests that neither he/she, nor any member of their household, is a party to litigation involving DOJ/NIC, including administrative proceedings, or is a party to any protest before DOJ/NIC.
4. Contest participant attests that neither he/she, nor any member of their household, is a party to litigation involving FHI 360.
5. Contest participant attests that all statements made in the presentation are true to the best of his/her knowledge.
6. Contest participant attests that he/she has not used any federal funding, whether grant, contract or loan proceeds in the development and/or production of their presentation entry.

Payment

1. Contest participant(s) acknowledge that he/she has not received, nor will receive any compensation for the use of personal information, including but not limited to personal appearance, likeness, name and/or address and/or the presentation submitted by Contest participant.
2. Contest participant(s) acknowledges that he/she has no expectation of any compensation or reimbursement for expenses incurred in connection with selection of Contest participant as a winner.

Publicity

Contest participant consents to use by the Hosts and their agents of Contest participant's name(s), likeness, photograph, voice, opinions, and/or hometown and state for promotional purposes in any media, worldwide, without payment or other consideration.

Liability and Insurance

1. Contest participant shall be liable for, and indemnify and hold harmless the Federal government and FHI 360 against, any and all claims which arise from or are in any way connected with the use of Contest participant's personal information and/or presentation, including but not limited to loss of, or damage to property resulting from the fault, negligence, or wrongful act or omission of the Contest participant.
2. Contest participant agrees to assume any and all risks, and to waive any and all claims against the Federal government and its related entities and/or FHI 360 for any injury, death, damage, or loss of property, revenue, or profits, whether direct, indirect, or consequential, arising from his/her development of their presentation or otherwise from participating in this Contest.
